I. Call to Order and Welcome

- The finances look good. We had a couple of reasonable increases the last couple of years that have left us in good shape.
- Jim thanked Pinehurst for another year of a job well done. In addition to the good work Sarah does, how a management company handles the money is very important and Jim rated Pinehurst very highly on how they handle the HOA's funds.

III. 2024 Annual Meeting Minutes Approval

A motion was made and seconded (Manning/Zehr) to approve the 2024 Annual Meeting Minutes as amended. Motion passed.

IV. **2024 Financial Report** (Sarah Kiernan)

Total Operating Expenses of \$382,706.59 were under budget by \$4,028.53 for 2024.

Total Reserve Contribution was \$56,998.23.

Budget Update

Las Palomitas dues increased roughly 2.5%. This was to help offset the Master Association dues increase. Most areas where the budget increased were due to an increase in the cost of goods and services, such as landscaping, insurance and utilities.

Monthly Reserve Contribution will be \$4,892.

V. Questions/Comments from Association Members (Owners)

- Monica is happy the walking path has been repaved, but it was only the LPAL section that was paved and the rest of the path is awful. She would like the Master Association to be urged to repave the remainder of the path as it presents a hazard for many older folks who tend to stumble and could fall and be injured. She asked the new Board to take that on and also for members to solicit the Master Association. Sarah reported it was up for discussion by the Master Association and she will check on the status.
- Monica would like the annual meeting to be an in-person. She also recalled having a spring pool party potluck in the past and would like that tradition revived.
- Judith asked why the speed sign hasn't been moved to near the turnoff into Ridge 4. She would like the stretch from the golf course to Chiquiri that people speed on to be monitored as it is at the other end. And to consider a STOP sign before turning into Ridge 4.

VI. Announcement of Election Results

36 ballots were submitted of 96 eligible - 38% of owners

Terry Davis – 31 votes
Jennifer Zehr – 29 votes
Hans Klaudt – 52 votes
Lynn McCanse – 32 votes
Helen Steinman – 32 votes
All were elected to the Board.

- Sarah thanked Jim for his service on the Board and looks forward to working with the new Board.
- Monica thanked the Board for the responsibility they have taken as well as Linda for her landscaping work.
- Linda mentioned Jim was on the landscaping committee and has been such a level head for the association and the landscape committee.
