Approval of Minutes of November 16, 2009

Financial Report

- > The November 2009 financials were reviewed with those present.
- > Delinquencies were discussed.
- The Board discussed being approximately \$7,000.00 or \$8,000.00 under budget and there are two Homeowners that are delinquent about \$9,000.00.

The Board requested that Ms. Weber find out if the excess becomes part of the Owner's equity.

- > The Board reviewed the Reserve Fund investment program.
 - A motion to authorize the Finance Committee and LMR to invest funds per the investment plan was made, seconded and passed with a unanimous vote.
- > The Board discussed why Ridge IV assessments are less expensive. Each owner is responsible to pay for their own insurance and they have more homes.
- The financials, including the 2010 Budget will be reviewed at the Annual Meeting.
- The 2010 Budget analysis, 2010 Budget and financial information will be available for all members at the Annual Meeting. Delinquencies will be discussed.
 - A motion to approve the November 2009 financial reports as presented was made, seconded and passed with a unanimous vote.
- > The Board discussed the continued \$6.00 charges for a water meter. Ms. Weber is working on this.
