#### I. Call to Order

The meeting was to order at 4:02 p.m. after establishing a quorum with 3 members participating via conference call.

## II. David Rishor – Light Sync

- David entertained questions regarding the lights fixtures from Ultralights and Hinkley Lighting. He
  explained the lights will have a closed top because of the night sky ordinance.
- Donna commented about finishes and indicated owners would have choices to a certain extent.
- David emphasized that the new lighting would be consistent throughout the community and that
  the Ultralights can likely suit everybody's taste. He estimated the cost for 100 houses would be
  about \$120 per house/per fixture. He was asked to provide a proposal, including installation, for
  both the Ultralights and the Hinkley lights for 100 houses.

### **Discussion:**

- Donna emphasized wanting to give the community a more modern look, and reviewed how the issue of changing the lights arose.
- The consensus was that if the HOA doesn't cover the cost, the lights won't get changed. Donna will put it on the agenda next month. Estimated total cost is \$20,000.

#### V. Financial Report (J. Mitchell)

The Balance Sheet is in good shape.

- Reserves expenses: \$1,340 for lighting and irrigation.
- Dues income: \$251,200 YTDTotal Income: \$253,931.92 YTD
- Total expenses: under budget by \$2,482.33.
- Administrative: under budget \$2,140.89.
- Maintenance: under budget \$339.50.
- Utilities: under budget \$9435.
- Net operating income: \$51,607.94
- Jonathan suggested laddering the CDs and picking up 2% interest. The projection is there will be \$162,000 available at end of year, and only need \$82,000 in account. Jonathan will keeping rolling the CDs as they come due unless something changes with the budget.
- Have \$5m and \$3m insurance.
- 5 year warranty on painting. Jon requests company info to call them.
- Everything looks great.

A motion was made and seconded (Mitchell/J Davis) to ladder \$60,000 in 3 CDs: \$20,000 each in a 3 month, 9 month and 12 month CD. Motion passed

A motion is made and seconded (Falsgraf/J Davis) to accept Financial Report of September 2018 as presented. Motion passed.

Donna will ask Carrie to figure out the numbers for the CDs and copy Jonathan.

- 2019 Budget
- Everything looks good except water. A 5% increase is in line for utilities.
- Donna has budgeted \$7500 to take care of tree overgrowth.
- Gravel amount is based on reserve study
- Only \$2,800 out of \$20,000 budgeted was spent for landscaping this year.

A motion was made and seconded (Falsgraf/J Davis) to approve the 2019 budget as presented. Motion passed.

## **September Financials**

Operating Expense: \$ 61,601.89
Reserves: \$143,669.24 **Total Assets:** \$205,271.13

**Income:** We are on target with our dues income.

**Administrative Expenses**: under budget by \$2,140.89, which is insurance. YTD we are under budget \$4,038.08.

**Maintenance**: Just slightly under budget by \$339.50 for tree planting and landscape service.

**Utilities**: We are under budget by \$1.94 and water over budget by \$252.54. Water continues to be over budget \$110.48 and YTD over budget in water is \$2,819.61 (irrigation and in April drained the spa for repairs).

### La Paloma DRC

- Jeff Obral called and asked if Las Palomitas would consider having someone represent them in the DRC committee, which meets monthly. He also asked if we were moving forward on the landscaping update. I stated those plans were on hold until we decided which sections would be the highest priority and work from there.
- Donna will try to solicit owners for the DRC Committee.

#### **Pool Area:**

There have been no issues in the pool area.

## Landscaping:

• I believe our landscapers are doing a great job. We have received comments from owners about getting some trees trimmed that are hanging over the roofs. We have about \$7,500 in the DRAFT budget for this specific purpose.

### **Javalina Issues:**

 We are on the last month of weekly spraying with vinegar to mitigate this back area (behind the north area of Chiquiri) from being a javalina trail. It seems to be working as there has only been a lone javalina braving the vinegar scent. It costs \$50 a week to spray the vinegar.

 We have the meeting scheduled for October 23. Important to have former Board members present.
