➤ The Board reviewed the December 21, 2015 Board Meeting Minutes.

A motion to approve the December 21, 2015 Board Meeting Minutes as amended, was made by Terry Davis, seconded by Ray Soule and passed with a unanimous vote.

Financial Report

- > The September, October, November and December 2015 financials were reviewed with the board
- > September began with \$165,000.00 in Reserves.
- Norris Designs was paid \$345.00.
- > \$8,000.00 was transferred from Reserves to Operating to pay outstanding invoices.
- ➤ In October, the \$8,000.00 was transferred back to Reserves from Operating.
- ➤ In November, there was \$166,800.00 in Reserves.
- ➤ \$36,000.00 was paid to AAA Landscape for irrigation installation.
- > \$1,089.00 was paid to Norris Designs for consulting on the irrigation project.
- ➤ In December, pool and spa pumps were purchased and paid for out of Reserves.
- > \$18,000.00 was paid to AAA Landscape.
- At year end, there was \$115,400.00 in Reserves.

- ➤ Overall, we spent less than budgeted in 2015.
- Electric was over \$1,500.00 year-to-date.
- Water was over \$4,500.00 year-to-date.
- ➤ Janitorial service was over \$2,700.00 year-to-date.
- ➤ Gas was \$1,000.00 under budget year-to-date.
- The trash and recycling contract was renewed and \$1,200.00 was saved year-to-date.
- ➤ Overall, AAA Landscape charged \$13,013.00 under contract.
- Norris Designs anticipated more onsite visits and will reduce their contracted amount as well.

A motion to approve the September, October, November and December 2015 financials was made by Monica Manning, seconded by Terry David and passed with a unanimous vote.

- > The men's restroom toilet at the pool was repaired.

- ➤ The claim came out to total \$5,006.00.

- ➤ The Board opted to withdrawal from the claim.
